

## **Slip End Playing Field Management Committee**

### **No Smoking Policy – as at May 2025**

Slip End Playing Field Management Committees No Smoking Policy seeks to guarantee the right of all trustees, users and visitors to breathe air free of tobacco smoke and to comply with smoke-free legislation: The Health Act 2006 and The Smoke-free Premises etc. (Wales) Regulations 2007.

Passive smoking has been medically proven to cause lung cancer and heart disease in non-smokers, also been proven to cause asthma and migraine attacks, as well as other serious illnesses and minor conditions.

#### **The Penalties for Non-Compliance with Legislation**

Failing to display no-smoking signs in premises covered by the law (£200 fixed penalty notice, or up to £1000 Court fine);

Smoking in a smoke-free place (£50 fixed penalty notice, or up to £200 Court fine);

Failing to prevent smoking in a smoke-free place (up to £2500 Court fine).

#### **The Management of This Policy**

Therefore, it is the policy of Slip End Playing Field Management Committee that all our areas are smoke free, and all users and visitors have a right to operate in a smoke free environment. Smoking is not permitted in any part of the premises including lifts, corridors, stairways, kitchen, toilets, meeting rooms, toilets, reception areas, entrances/exits at any time, by any person regardless of their status or business with Slip End Playing Field Management Committee, except by users and visitors in the externally designated area(s).

#### **Adequate Signage and Facilities for Disposal of Smoking Refuse, etc.**

Trustees are responsible for ensuring the implementation and maintenance of this policy. Appropriate 'no-smoking' signs will be clearly displayed at the entrances to and within the premises. Smokers are responsible for disposal of cigarette litter including discarded cigarette butts, cigarette packets, matches and match boxes. Smoking litter should be disposed of in designated bins and not discarded on the ground.

#### **Enforcement of the Smoke-Free Legislation**

Council enforcement officers will have the power to enter no-smoking premises to determine whether the law is being upheld. They also assess whether those in control of the premises have taken all reasonable precautions to avoid people smoking.

All hall users and visitors have a personal responsibility in ensuring their personal compliance and in ensuring that all those who enter the premises are made aware of the policy. Those who do not comply with the smoke-free law may be liable to a fixed penalty fine and possible criminal prosecution.
